The meeting was opened with prayer by Pastor Farmer.

Minutes of the March Church Board Meeting and the Financial Report for March were reviewed. **Gary Suber** made a motion to approve the minutes and **Ed Hood** seconded the motion. The Board approved the motion.

### **DEPARTMENT REPORTS:**

**NYI:** Cory McCracken reported the Youth Lock-In was well received and well attended.

**NMI:** All NMI budgets have been paid and the missions goals are near completion.

**Stewards:** Contacts and planning continue with regard to our 75th Anniversary Homecoming.

The motion was made to underwrite the expense of Brooklyn and Colleen Sheets to attend that meeting. **Doug Eldridge** made a motion that we pay the expense of this trip in the amount of \$225.00. **Ricky Wood** seconded the motion. The Board approved the motion as stated.

A **VBS Budget** of \$1700 was presented which includes a DVD driven interactive program. Plans are to take a special offering to help cover the cost of meals which is \$700 of the \$1700 budget requested.

**Gary Suber** made the motion to approve the \$1700 budget for VBS expenses. **Ricky Wood** seconded the motion. The Board approved the motion.

The Board approved by unanimous consent the advertising of upcoming church events.

**Ed Hood**, Chairman of the Trustees, presented the recommendation of the Board of Trustees for a \$2500 increase in the Pastor's annual salary effective May, 2006, the beginning of the next fiscal year.

**Doug Eldridge** made a motion that we increase the Pastor's annual salary by \$2500 effective May, 2006, and that how the increase is designated be left to the Pastor's discretion. **Cindy Eunice** seconded the motion.

The Board unanimously approved the motion.
